This is to inform that the Company has filed a writ petition yesterday i.e. September 1, 2023 at 11.45 am, before the Hon'ble High Court of Punjab and Haryana at Chandigarh ("Hon'ble Court") against State of Punjab and Others, *inter-alia*, praying for quashing of show cause notice issued by Greater Mohali Area Development Authority for resumption of a plot of land measuring 5 Acres in Medicity in New Chandigarh and demanding Rs.41,50,48,000/-(Rupees Forty Crore Fifty Lakhs Forty-Eight Thousand only) towards balance instalment for plot of land, interest and penalty.

	Brief details of litigation:
	 The Company vide, an Allotment Letter in 2015, was allotted a plot of land measuring 5 Acres in Medicity in New Chandigarh for medical facilities on lease cum free hold sale basis for the purpose of multi-specialty hospital project. A lease deed was executed by GMADA and sent to Company. The Company made partial instalment payment of Rs.16,26,00,000/- (Rupees Sixteen Crore Twenty-Six Lakhs only) for the plot of land. The Company was asked to take possession of plot of land in July 2015. However, the Company did not get the vacant and peaceful possession of the plot of land for construction of hospital despite request letters to remove the encroachments. GMADA issued a show cause notice for resumption of aforesaid plot of land and demanding Rs. 41,50,48,000/-(Rupees Forty Crore Fifty Lakhs Forty-Eight Thousand only) towards balance instalment of purchased of plot of land, interest and penalty. The Company filed a writ petition before the Hon'ble High Court of Punjab and Haryana at Chandigarh praying for quashing of aforesaid show cause notice for resumption and
